MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR MAY, 2016

- 1. National Capital Goods Policy approved by the Cabinet:** The Cabinet in its meeting dated 25th May, 2016 approved the National Capital Goods Policy. This is the first ever policy for Capital Goods Sector with a clear objective of increasing production of capital goods from Rs. 2,30,000 crore in 2014-15 to Rs. 7,50,000 crore in 2025 and raising direct and indirect employment from the current 8.4 million to 30 million.
- 2. Meeting of the Committee on Loss Making/Sick/Non-Performing CPSEs:** Secretary HI, attended the meeting of the Committee on Loss Making / Sick/ Non-Performing CPSEs held on 3rd May, 2016 under the chairmanship of Vice-Chairman, Niti Aayog. Report finalized by the Committee in this regard has already been submitted to Prime Minister's Office.
- 3. A meeting of Group of Secretaries under the chairmanship of CEO, NITI Aayog:** In view of the ban imposed by Hon'ble Supreme Court on the registration of diesel vehicles above 2000 cc in NCR, a meeting of Group of Secretaries under the chairmanship of CEO, NITI Aayog was held on 23rd April 2016. As per the decision taken in this meeting, Department of Heavy Industry impleaded itself in the matter of M.C. Mehta & Ors vs. UOI & Ors. for the hearing fixed on 9th May 2016 so as to apprise the Hon'ble Supreme Court about the measures taken or contemplated by the Government to balance the requirements of protecting the environment and carrying out sustained economic development, which is being guided through the "Make in India" Campaign.
- 4. Apprehension of extending ban on registration of diesel vehicles by National Green Tribunal (NGT):** In the apprehension of extending ban on registration of diesel vehicles above 2000cc by National Green Tribunal (NGT) in the 11 cities, under consideration of Tribunal with regard to their air pollution in the matter of Vardhman Kaushik & Ors. Vs. UOI & Ors., another application was filed in the National Green Tribunal (NGT) on 28th May 2016 for impleadment of Department of Heavy Industry so as to present the coordinated views of the GOI.
- 5. Meeting of Internal Scrutiny Group (ISG) under the chairmanship of Joint Secretary (Auto), DHI :** The meeting of Internal Scrutiny Group (ISG) under the chairmanship of Joint Secretary (Auto) was held on 6th May 2016 to assess the

suitability of projects/ proposal received under FAME India Scheme, so as to place them before the Project Implementation & Sanctioning Committee (PISC) for sanctioning grant/incentive under the scheme.

- 6. Triveni Structurals Limited has been under liquidation as per Hon'ble High Court of Allahabad:** Triveni Structurals Ltd. has been under liquidation as per Hon'ble High Court of Allahabad order dated 8.10.2013. A proposal is under consideration to offer VRS/VSS to its employees. CCEA Note in this regard is under inter-ministerial consultation.
- 7. Pragati Meeting held on 25th May, 2016 at Jharkhand for Modernization & Expansion of Bhilai Steel Plant, Steel Authority of India Limited -:** The Pragati Meeting dated 25th May, 2016 regarding Modernization & Expansion of Bhilai Steel Plant, Steel Authority of India Limited, Jharkhand was attended by the Secretary, DHI. Secretary, DHI alongwith Secretary, Ministry of Steel had a detailed review with all stakeholders on 17th May and had worked out a road map for completion of the project.
- 8. A meeting of Public Enterprises Selection Board (PESB) held on 18th May, 2016 reg- Selection for the post of CMD, HMT Ltd:** Secretary, HI attended the meeting of Public Enterprises Selection Board (PESB) on 18th May, 2016 regarding selection for the post of CMD, HMT Limited. The name of Shri Girish Kumar, CMD, HMT International was recommended by the Board for the said post.
- 9. Framing of draft CEMM Bill was entrusted with to M/s. PLR Chambers on the request of Industry Association, ICEMA:** On the request of the Industry Association, ICEMA, the work of framing of draft CEMM Bill was entrusted with to M/s. PLR Chambers which is well-known legal firm with experience in this area. The draft CEMM Bill has been prepared and interaction with the industry is taking place to seek their views.
