Monthly Summary of Significant Activities for February, 2018

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of February, 2018 in the Department of Heavy Industry (DHI).

1. Hon'ble Minister (HI&PE) inaugurated the 14th edition of the Delhi Auto EXPO-2018 on 8th February, 2018. The six day Motor Show registered footfall of more than 6 Lakh and witnessed over 500 product displays from 119 exhibitors including 53 OEMs. In this Motor Show, more than 25 models of electric vehicles were on display.
2. The foundation stone of Tumakuru Machine Tool Park was laid on 10th February, 2018 at Vasanthanarasapura, Tumakuru District, Karnataka by Shri Anant G. Geete, Hon'ble Minister for Heavy Industries and Public Enterprises, Government of India. Department of Heavy Industry is providing a grant of Rs.125 Crore for the Park – and has already released Rs. 25 Crore.
3. Under the ongoing EoI on shared and public e-mobility under the FAME scheme, nine out of 11 selected cities placed Lols for purchase of buses by the deadline of 28.02.2018, Delhi and Ahmadabad failed to meet the deadline and were disqualified from further process as per the terms of EoI. The competition among suppliers under the EoI has led to substantial fall in prices of electric buses.
4. Draft of the new National Automobiles Policy was uploaded on the website of DHI for soliciting comments of stakeholders.
5. Based on the recommendations of COS, a draft CCEA note on closure of Hooghly Printing Company Limited (HPCL) and its merger with Andrew Yule & Company Limited (AYCL) with all its assets, liabilities and employees was circulated for inter ministerial consultation on 28th February, 2018.
6. The Land Management Agency i.e. NBCC (India) Ltd. has since concluded the re-tender process for disposal of land and buildings of the CPSEs under closure. They have recommended sale of some immovable assets of 2 CPSEs namely, Hindustan Cables Ltd. and Instrumentation Ltd. (Kota) for which bids were received from Central Government entities.
7. A Meeting of Department Related Parliamentary Standing Committee on Industry was held on 21st February, 2018 to consider and examine the Demand for Grants of DHI for the year 2018-19.
8. Secretary (HI) chaired a meeting of the committee constituted by NITI Aayog on Demand and Supply side incentives for promotion of electric mobility on 22nd February, 2018, and finalized the outline of the proposals to be included in the concept note for the next

phase of the FAME scheme.

9. Secretary (HI) held a meeting of Inter-Ministerial Group (IMG) on 22nd February, 2018 to finalize the statement of objection for challenging jurisdiction of International Arbitral Tribunal in the matter of dispute raised by Nissan Motors Limited before the Permanent Court of Arbitration (PCA), Hague, and the counter-Memorial on Jurisdiction/ Admissibility objections was filed on 24th February, 2018.

10. Under the umbrella of 2nd India-Korea Business Summit, DHI organized the Sectoral Session on Automobile Industry on 27th February, 2018 which was attended by Hon'ble Minister (HI&PE) and Secretary (HI) besides high level participants from India and Korea.

11. Braithwaite Burn and Jessop Construction Company Limited (BBJ) has received an order from Northeast Frontier Railway for parts of 21 Major Bridges in connection with the construction of new BG railway line from Bairabi to Sairang (Mizoram) in consortium with ABCI Infrastructures Pvt. Ltd. at a total cost of Rs. 667 Crore.

12. Hon'ble Vice President of India Presented 27 Prime Minister's Shram Awards to employees of Bharat Heavy Electricals Ltd. (BHEL). The 27 awards include 4 Shram Bhushan, 10 Shram Vir / Veerangana and 13 Shram Shree / Devi awards for the years 2011-2016. The awardees include 8 women employees from BHEL out of the total 20 women employees awarded at the national level.

13. A Cheque of Rs.185 Crore towards 40% interim dividend was presented to Hon'ble Union Minister & Hon'ble Minister of State for Heavy Industries & Public Enterprises by CMD, BHEL for the year 2017-18.

14. MoU was signed between BHEL and Government of Uttar Pradesh for setting up 1×800 MW Obra 'D' and 1×800 MW Anpara 'E', supercritical power stations in Uttar Pradesh through Joint Venture (JV) with Uttar Pradesh Rajya Vidyut Utpadan Nigam Limited (UPRVUNL).
